## THE PUBLIC INTEREST DISCLOSURE (WHISTLEBLOWER PROTECTION) ACT

The Public Interest Disclosure (Whistleblower Protection) Act came into effect in April 2007. This law gives employees a clear process for disclosing concerns about significant and serious matters (wrongdoing) in the Manitoba public service, and strengthens protection from reprisal. The Act builds on protections already in place under other statutes, as well as policies, practices and processes in the Manitoba public sector.

Wrongdoing under the Act may be: contravention of federal or provincial legislation; an act or omission that endangers public safety, public health or the environment; gross mismanagement; or, knowingly directing or counseling a person to commit a wrongdoing. The Act is not intended to deal with routine operational or administrative matters.

A disclosure made by an employee in good faith, in accordance with the Act, and with a reasonable belief that wrongdoing has been or is about to be committed is considered to be a disclosure under the Act, whether or not the subject matter constitutes wrongdoing. All disclosures receive careful and thorough review to determine if action is required under the Act, and must be reported in the Corporation's annual report in accordance with Section 18 of the Act. Manitoba Film & Music did not receive any disclosures for the fiscal year ending March 31, 2019.

# THE CORPORATION


The Manitoba Film and Sound Recording Development Corporation, known as Manitoba Film & Music (MFM), is a statutory corporation of government proclaimed under the Manitoba Film and Sound Recording Development Corporation Act funded by the Province of Manitoba through the Department of Sport, Culture and Heritage. The management of Manitoba Film & Music reports directly to the Board of Directors appointed by the Lieutenant Governor in Council.

MFM supports Manitoba music and screen-based industries through our objectives, which are to create, stimulate, employ and invest in Manitoba by developing and promoting Manitoba companies, as well as producing and marketing film, television, video and music recording projects. MFM also promotes Manitoba as a film location for international productions.

## GREETINGS FROM THE CHAIRPERSON AND CHIEF EXECUTIVE OFFICER

**On behalf of the Manitoba Film & Music (MFM) Board of Directors and staff, we are pleased to present the corporation's annual report for the fiscal year ending March 31, 2019.**

The title of this year's report 'Taking Off: New Frontiers in Film & Music' speaks to the palpable energy and optimism felt in Manitoba's film and music industries today. The sector is at a tipping point, primed for unprecedented growth and creative expansion.

This year, the province saw nearly \$270 million in film production – shattering previous records and positioning Manitoba as a competitive, next-level production centre. The Government of Manitoba's announcement regarding the permanence of the Manitoba Film & Video Production Tax Credit will allow for even further growth – creating stability, jobs and significant economic impact throughout the province. Following the announcement, the major big-budget Amazon/Fox series *Tales from the Loop* pulled the trigger on shooting the project here in Manitoba – demonstrating the value of stability when it comes to provincial film incentives. Other production highlights from the year include the filming and release of season two of the CBC series *Burden of Truth* (currently greenlit for season three, which will shoot in Manitoba August 2019), *Percy* (a Canadian story starring Christopher Walken which was co-developed and co-produced here in Manitoba), and *A Dog's Journey* (which marked the

return of Amblin, following the success of *A Dog's Purpose*), among many others. This year, the LA-based management and production company, The Cartel, launched a subsidiary in Winnipeg called Cartel Pictures Canada, bringing 5 projects to Manitoba in this fiscal year alone. We highlight these milestones and others in the 'Spotlight' section of this report.

In music, Manitoba's artists continue to garner national and international accolades. This year, MFM-funded musicians received 3 JUNO nominations, 8 Western Canadian music award nominations and 2 Canadian Folk Music Award nominations. Our province's Indigenous artists had a significant impact this year with JUNO nominations (Leonard Sumner), a BBC radio special (William Prince) and major international tours. Some of Manitoba's major musical acts, including Royal Canoe, Begonia, Yes We Mystic and others continue to receive rave reviews, have their music

placed in Hollywood films, and sign with major management companies. Further details can be found in the 'Spotlight' section of this report.

In closing, we would like to thank all those who make these industries what they are. Thank you to MFM's outgoing Board Members Linda Allen, David McLeod, Kim Jasper, Shirley Muir and Mariette Mulaire for your dedicated service. Thank you as well to outgoing Chair Diane Gray for your extraordinary service, leadership and dedication to the Corporation.

Thank you to our incredible industry associations Manitoba Music and On Screen Manitoba. Thank you to the Province of Manitoba and the City of Winnipeg for making this a film-friendly place to do business. Thank you to the Winnipeg Film Group, Film Training Manitoba, New Media Manitoba, the National Screen Institute, the National Film Board, Telefilm Canada, the CMF, the CMPA, FACTOR Canada and CIMA for your help in ensuring our film and music industries flourish. Thank you to those who participate on our juries. Thank you to the MFM staff who work tirelessly every day to support and champion our clients. Thank you to our Board of Directors who volunteer their time and give so much to MFM. And finally, we want to thank the Manitobans who support local artists and creators. It is thanks to this homegrown support that our filmmakers, musicians and industry professionals are able to thrive here and around the world.



# Thank You Carole Vivier

After a 30 year career with Manitoba Film & Music, 2019 marks the retirement of CEO & Film Commissioner Carole Vivier. During her time in the industry, Carole has been at the forefront of developing Manitoba's film and music industries into international success stories.

She has heralded the growth of Manitoba's production sector from a modest industry accommodating 8 projects per year, to a \$269 million industry in 2019. Carole, through her work as the Film Commissioner, was instrumental in attracting such high profile projects as *Channel Zero*, *Heaven is for Real*, *A Dog's Purpose*, *A Dog's Journey*, *Shall We Dance*, *Tales from the Loop* and *Capote* (among many others) to shoot in Manitoba and co-produce with local production companies. In music, Manitoba remains one of the country's most supportive provinces for artists – due in no small part to Carole's leadership at Manitoba Film & Music. Carole was instrumental in bringing the JUNO Awards to Winnipeg in 2005 and 2014, and supporting the careers of major Manitoba acts including Chantal Kreviazuk, Doc Walker, Vince Fontaine, Royal Canoe, Begonia and many others. She is a recipient of the Order of Manitoba, the Queen's Diamond Jubilee Medal and the Canadian Screen Awards Academy Board of Directors Tribute. She is also a member of the Manitoba Business Hall of Fame.

Carole has been described as the 'Lioness' of film and music in Manitoba. She is a fierce advocate for the province and

a champion for Manitoba creators. Her passion for the work of filmmakers and musicians in Manitoba has touched thousands of lives and propelled many careers. She will be so greatly missed.

# IN THE SPOTLIGHT

## PROVINCE MAKES TAX CREDIT PERMANENT

In a major vote of confidence for Manitoba's screen-based industries, the Province of Manitoba announced on January 15, 2019 that the Manitoba Film & Video Production Tax Credit would be made permanent. At On Screen Manitoba's All Access forum, Minister of Sport, Culture and Heritage Cathy Cox received a standing ovation from the industry following the announcement, which highlighted the Province's recognition of the value of the industry. The removal of the sunset clause on the tax credit sends a message to the global film industry that Manitoba is open for business for the long term. It particularly impacts MFM's ability to attract major series to the province, as productions want to ensure stability over multiple seasons.

Following the Province's announcement, the major Amazon/Fox 21 Television Studios series *Tales from the Loop* confirmed they would be filming in Manitoba. This announcement provides even further momentum for Manitoba screen-based industry, which is currently breaking production volume records and creating significant economic impact. The potential for growth has never been greater. This is truly a tipping point for the industry.





## INDIGENOUS ARTISTS ON THE WORLD STAGE

Manitoba's Indigenous artists have been creating a major impact in recent years with international tours, radio specials, awards, nominations and more. Since emerging on the music scene just a few short years ago, William Prince has taken the music industry by storm. His first full-length album 'Earthly Days' garnered him a JUNO Award for Contemporary Roots Album of the Year and a Western Canadian Music Award for Aboriginal Album of the Year. Prince, who is signed with Glassnote Records released 'Earthly Days' worldwide this year, which garnered a major BBC radio special and several international tour dates. Leonard Sumner, an Anishinaabe singer-songwriter from Manitoba, received a Juno Award nomination for Indigenous Music Album of the Year for 2019 and received several prestigious bookings both in Canada and around the world. Indian City, one of Manitoba's mainstay Indigenous acts received 3 nominations at the Indigenous Music Awards and won Best Pop Album for their recent release 'Here & Now'.

## THE CARTEL COMES TO MANITOBA

L.A.-based management and production company The Cartel expanded its operations to Canada this year with the launch of a new subsidiary, Cartel Pictures Canada, located in Winnipeg. The company, which had previously shot four Hallmark MOWs in Winnipeg, focuses on production, development and financing of MOWs, indie films and TV series. In this fiscal year, Cartel Pictures Canada shot 5 projects in the province. When the opening of the subsidiary was announced, the company stated that they planned to produce half of their projects in Winnipeg – around 10 projects total in 2019.



### TALES FROM THE LOOP

Following the announcement of the permanence of the Manitoba Film & Video Production Tax Credit, Amazon and Fox 21 Television Studios announced they would be filming the major series *Tales from the Loop* in the province. The project has already begun shooting in Winnipeg, Morden and surrounding areas. The science fiction drama is based on the work of Swedish painter Simon Stalenhag, who blends elements of futuristic science-fiction with images of rural life. Series are particularly beneficial because they allow for long-term crew employment, extensive training opportunities and increased inward investment to the province.

### ARIEL POSEN SIGNS WITH MAJOR MANAGEMENT

Manitoba guitarist and singer-songwriter Ariel Posen signed with David Meszaros of Macklam Feldman Management this year, joining an impressive roster of clients which include Elvis Costello, Diana Krall and James Taylor. Posen is a former member of the JUNO Award winning, roots-rock band The Bros. Landreth. His long-awaited solo debut album 'How Long' is a roots album peppered with a hint of the blues described as "a mix between R&B and melodic rock and roll".

## MANITOBA PRODUCTIONS, CANADIAN STORIES

This year saw the realization of a major Manitoba project. The feature film musical *Stand!*, written, composed and produced by Manitobans, was filmed in the province using 94% Manitoba actors and nearly a full Manitoba crew. Written by Danny Schur and Rick Chafe, *Stand!* tells the story of the 1919 Winnipeg strike, an event that forever changed labour relations in Canada. The film will be released in 2019 (the 100th anniversary of the strike) and will be screened as part of MFM's Red Carpet Screening series at the Centennial Concert Hall in September 2019. *Stand!* is produced by Jeff Peeler of Frantic Films and directed by *Bring it On* and *Stomp the Yard* director Robert Adetuyi.

The film *Percy*, which tells the story of Saskatchewan farmer Percy Schmeiser who took on Monsanto in a legal battle, was filmed, co-developed and co-produced in Manitoba this year. The film, which stars major talent including Christopher Walken, Christina Ricci and Adam Beach, used 78% Manitoba cast and was co-produced and co-developed by Manitoban Ian Dimerman of Inferno Pictures.

## MANITOBA AT THE JUNOS

MFM-funded artists landed three JUNO nominations this year. KEN mode's album 'Loved' (supported through MFM's Level 3 Recording fund) and the Cancer Bats album 'The Spark That Moves' (supported through MFM's Out of Province Recording fund) were both nominated for Metal/Hard Music Album of the Year. Leonard Sumner's new album 'Standing in the Light' (supported through MFM's Level 2 Recording fund) was nominated for Indigenous Music Album of the Year.

### INDIGENOUS FILM SUMMIT

This year, MFM was a sponsor of the inaugural Indigenous Film Summit, an initiative led by Manitoba's Indigenous Film Collective. The summit is aimed at emerging and professional writers, directors, and producers – providing them a space to come together, share ideas, and network with some top professionals in the industry. The featured keynote speaker was actor/producer Tina Keeper. The event was a major success, well received by the over 200 delegates and industry professionals.

### GIMLI FILM FESTIVAL

MFM has been a long-time supporter of the Gimli Film Festival. This year, the festival drastically increased its industry development initiatives – focusing on capacity building and showcase opportunities for Manitoba's female and Indigenous filmmakers. This was the inaugural year of the festival's Future is Female Mentorship Program, aimed at involving more women-identified, trans and non-binary people in the Gimli Film Festival and the greater filmmaking community. The program transported 45 participants to Gimli by bus for a day of capacity-building, screenings and mentorship. This was also the first year for the festival's Indigenous Film Series, which focused on showcasing projects by Indigenous people from Manitoba, Canada and around the world. MFM also sponsored the Manitoba Short Film Audience Choice Award, which celebrates excellence in short film making in the province.

# FILM & TELEVISION IN MANITOBA

MFM exists so that Manitoba's film and television industries flourish.

We achieve this by developing and promoting Manitoba companies, supporting the development, production and marketing of film and television projects through our programs, as well as promoting Manitoba as a film location to offshore production companies. Our objectives are to enhance Manitoba's screen-based industries, thereby increasing employment, intellectual property and copyright ownership and stimulating business for local service providers.

MFM is a long-standing member of the **Association of Film Commissioners International** (AFCI). In addition to administering film programs and tax credit incentives, MFM is a full-service film commission that offers a broad range of location services including script breakdown, location scouting as well as government, business and industry liaison services. MFM has helped attract hundreds of films and television programs including *Heaven is for Real*, *A Dog's Purpose*, *Percy*, *Siberia*, *Channel Zero*, *Tales from the Loop*, *Burden of Truth*, *Capote*, *Shall We Dance* and many others.

This past fiscal year, \$269.4 million in production took place in Manitoba – shattering the previous year's record of \$173.3 million. This figure represents the total budgets for films that shot in Manitoba at some point between April 1, 2018 and March 31, 2019.

Through its film programs, administered by MFM, the province supported 8 feature films, 34 television series (fiction and factual), 15 one-off documentaries, 10 movies of the week, 2 pilots, 1 mini-series, 2 Web series and 3 short films. This year MFM received 129 scripts/project inquiries and provided 15 full scouts through the Film Commission for projects for Manitoba co-production and service production.

MFM has been a longtime supporter of the National Screen Institute's Indigenous programming including the New Indigenous Voices program and Indigidocs. These programs have helped create a strong base of Indigenous filmmakers in Manitoba who are gaining recognition in Canada and around the world. Graduates of these programs have launched the Indigenous Film Collective – a non-profit organization dedicated to the inclusion of the Indigenous experience in film, promoting societal dialogue, the empowerment of Indigenous filmmakers and public accessibility to Indigenous stories. This group also coordinates the Indigenous Film Summit, an extremely successful annual event that brings filmmakers together for capacity building, mentorship and more.



# FILM & TELEVISION PRODUCTION ACTIVITY

The total production value in the 2018/2019 fiscal year was \$269.4 million



Note: These figures represent film and television production activity reported as of fiscal year ending March 31, 2019. Multi-year projects are recorded as taking place in the first year of production.

## TAX CREDIT

Along with Manitoba Film & Music's equity financing, The Manitoba Film and Video Production Tax Credit is essential in attracting production to the province and allows Manitoba's production companies to continue to produce content. Manitoba's competitive tax credit is a key factor in our ability to create local employment opportunities and attract significant economic investment. A total of 128 tax credit applications were processed during the fiscal year. This represents \$306 million in production activity. Note: tax credit applications are not necessarily processed in the same fiscal year that production took place, which explains why the production volume and tax credit totals differ.

## FILM – OTHER DOLLARS LEVERAGED

With Manitoba's equity financing and estimated tax credit support totaling \$49.8 million, \$269.4 million in Manitoba co-production and foreign production activity occurred in this fiscal. This means that approximately 81% of total investment was leveraged from other sources from outside the province. Manitoba's modest but invaluable investment continues to attract millions of dollars in additional revenues into Manitoba's economy.

# MUSIC IN MANITOBA

MFM exists so Manitoba's music industry flourishes.

We achieve this by offering a series of music funding programs to help enhance and foster the province's vibrant music industry. MFM also attends and supports a variety of music festivals, conferences and showcases to maximize the impact of our funding by marketing our clients and creating business networking opportunities for Manitoba artists.

This year, MFM provided \$506,284 in funding toward 175 music initiatives- making our investment the key element of support to Manitoba's emerging and established musicians. Projects are funded through the Music Recording Production Fund (Levels 1, 2 and 3), the Recording Artist Touring Support Program, the Record Product Marketing Support Program, the Music Video & Viral Video Fund and the Music Recording Production Fund for Out-of-Province Artists. Music businesses are supported through the Music Business Development Fund.

Applications to MFM's music recording programs are evaluated through a juried process. Music recording proposals must be unanimously recommended for funding by a minimum of two juries. Juries are made up of local music industry professionals specializing in a specific genre of music. They may include producers, broadcasters, managers, label owners or representatives, artists, songwriters, media, and retailers. Manitoba Film & Music sincerely thanks all of the jurors who generously gave their time.

Applications to the Record Product Marketing Support Program, the Music & Viral Video Fund, the Recording Artists Touring Support Program and the Music Business Development Fund are evaluated by MFM based on project development plans, artist track records, touring schedules, strength of support team and distribution plans.


## MUSIC PRODUCTION ACTIVITY

During the 2018/2019 fiscal year, Manitoba Film & Music provided \$506,284 toward 175 initiatives including recording, touring, marketing and music video creation. Of these projects, 40 participants self-identified as Francophone, 13 self-identified as Indigenous, and 44 self-identified as cultural minorities.

MFM provided \$216,653 toward 57 music and music video recording projects with total estimated budgets of over \$600,000.

As funding for Manitoba artists from other sources is often limited, our investment is the key element of support for the province's emerging and established musicians. The graph indicates the crucial importance of MFM's investment in our local music recording industry.

## Market Access Program

As a program of the M3P project, the Market Access Program is supported with program assistance from Manitoba Film & Music and administered by Manitoba Music. # INDEPENDENT AUDITOR'S REPORT

NOTES TO FINANCIAL STATEMENTS

FOR THE YEAR ENDED MARCH 31, 2019

**1. Nature of the Organization and Summary of Significant Accounting Policies**

**Nature of the Organization**

Manitoba Film and Sound Recording Development Corporation (the “Organization”) is a statutory corporation created by the Province of Manitoba through The Manitoba Film and Sound Recording Development Corporation Act and is exempt from income taxes. The main objective of the Organization is to foster growth of the Manitoba film and music recording industries by providing financing and other assistance.

The Organization has been designated by the Minister of Finance to administer the Manitoba Film and Video Production Tax Credit Program, including the registration of productions and review of tax credit applications.

**Basis of Accounting**

The financial statements have been prepared using the Canadian public sector accounting standards for not-for-profit organizations as established by the Public Sector Accounting Board.

**Capital Assets**

Purchased capital assets are stated at cost less accumulated amortization. Amortization, is provided using the straight line method based on the estimated useful life of the asset, at the following rates:

### Program Funding

The Organization provides grant funding to Manitoba companies and individuals in order to promote Manitoba's film and music recording artists and industries. The grant may take the form of equity financing from which, in the future, there may be a recovery of principal or return on investment.

### Revenue Recognition

The Organization follows the deferral method of accounting for contributions. Unrestricted contributions are recognized as revenue as follows:

#### a) Province of Manitoba funding

Province of Manitoba funding is based on the Province of Manitoba's annual allocation to the Organization and is recorded as revenue on an accrual basis.

#### b) Program recoupments

Any recovery of principal or return on investment of programs funded is recorded as program recoupments when received.

#### c) Jump Start program recoupments

Any recovery of principal or return on investment of programs funded under the Jump Start program must be re invested in the Organization's Market Driven Television Production and Market Driven Feature Film Production financing programs within the fiscal year that the recoupment occurs, if possible. If not possible, recoupments will be deferred to the following fiscal year and recognized as revenue at that time.

### Short-term Investments

Short term investments consist of guaranteed investment certificates held with the Organization's financial institution, and are measured at cost less impairment.

Cash on deposit and internally designated cash earn monthly interest at the Chartered Bank's commercial rates. The Organization has internally designated a portion of its cash as noted above to satisfy commitments made as disclosed in Note 5 for carry over commitments.

### Use of Estimates

The preparation of financial statements in accordance with Canadian public sector accounting standards for not for profit organizations requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities at the date of the financial statements, and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from management's best estimates as additional information becomes available in the future.

### Financial Instruments

Financial instruments are recorded at fair value when acquired or issued. Cash has been designated to be in the fair value category. All other financial instruments are reported at cost or amortized cost less impairment, if applicable. Financial assets are tested for impairment when changes in circumstances indicate the asset could be impaired. Transaction costs on the acquisition, sale or issue of financial instruments are expensed for those items remeasured at fair value at each balance sheet date and charged to the financial instrument for those measured at amortized cost. Due to the nature of the financial instruments held by Manitoba Film & Sound Recording Development Corporation, there are no unrealized gains or losses, and therefore a statement of remeasurement gains and losses are not required for these financial statements.

**3. Short-term Investment**

Short-term investment consists of a guaranteed investment certificate with a maturity date of March 29, 2020, bearing interest at a rate of 0.60% per annum.

## **6. Industry Support**

The Organization indirectly supports the ongoing development of creative talent, business skills and capacity building of various film, television and music recording professionals by providing funding for specific programming administered by organizations such as Manitoba Music, On Screen Manitoba, the National Screen Institute Canada and the Winnipeg Film Group. Programs supported include Access to Markets, Indigenous Music Program, Features First, Drama Prize, Totally Television, New Voices and WFG First Film, as well as support to Post Production and Marketing funds.

## **7. Lease Commitments**

The Organization occupies leased premises subject to minimum monthly rent payments until August 2023, plus various equipment leases with quarterly payments until March 2022. Future minimum annual payments are as follows:

## **8. Program Delivery**

Program Delivery also includes the expenses associated with the delivery of the Manitoba Film & Video Production Tax Credit Program (“MTC”). While the value of the MTC does not flow through the Organization, the management of it does and is therefore determined to be worth nothing. The cost to administer the MTC Program in the fiscal year was approximately \$73,763 (2017 - \$78,560). A total of 133 applications were received for processing during the 2019 fiscal year (2018 - 132).

## **9. Capital Management**

The Organization's objective when managing capital is to safeguard the entity's ability to continue as a going concern, so that it can continue to provide financial and other assistance to applicants.

The Organization sets the amount of capital in proportion to risk and manages the capital structure and makes adjustments to it in light of changes in economic conditions and the risk of characteristics of the underlying assets. In order to maintain or adjust the capital structure, the Organization may decrease expenses or seek other sources of funding.

The Organization monitors capital on a quarterly basis, as well as annually, including the Board's input as to the capital management approach to take. There have been no significant changes in the Organization's capital management objectives, policies and processes during the year.

## 10. Employee Future Benefits

### a) Pension Benefits

Employees of the Organization are provided pension benefits by the Civil Service Superannuation Fund (the "Fund"). Under paragraph 6 of the Civil Service Superannuation Act, the Organization is described as a "matching employer" and its contribution toward the pension benefits is limited to matching the employees' contribution to the Fund. The Organization's contribution for the year was \$58,491 (2018 - \$58,280) and is included in employees benefits expense.

### b) Enhanced Pension Benefit Obligation

Certain employees of the Organization are entitled to enhanced pension benefits. A pension liability has been established for those employees whose annual earnings exceed the limit under the Civil Service Superannuation Fund Plan. The cost is actuarially determined using the projected benefit methods and reflects management's best estimate of salary increase and the age at which the employee will retire. The Organization measures its accrued enhanced pension benefit obligation as of December 31 each year. The most recent actuarial report was December 31, 2017.

The Organization has internally designated its short term investment (see Note 3) to meet its obligation for providing enhanced pension benefits to eligible employees.

## **11. Program Recoupments**

During the year the Organization received total program recoupments of \$243,506 (2018 - \$195,730) of which \$2,003 (2018 - \$2,912) related to the Jump Start program. These Jump Start recoupments were reinvested into new projects during the year.

## **12. Financial Risk Management**

In the normal course of operations, the Organization is exposed to various financial risks. Management's close involvement in the operations allows for the identification of risks and variances from expectations. The Organization does not meaningfully participate in the use of financial instruments to control these risks. The Organization has no designated hedging transactions. The financial risks and management's risk management objectives and policies are as follows:

### **Credit Risk**

Credit risk arises from the possibility that entities that owe funds to the Organization may experience financial difficulty and not be able to fulfill their commitment. The maximum exposure to credit risk is equal to the carrying value of the cash, short-term deposits and receivables. The risk has not changed in the year.

### **Interest Rate Risk**

Interest rate risk is the risk that changes in market interest rates may have an effect on the cash flows associated with some financial instruments, known as cash flow risk, or on the fair value of other financial instruments known as interest rate price risk.

The Organization is not exposed to interest rate cash flow risk as the Organization does not have any short-term or long-term debt. The risk has not changed in the year.

The Organization does not trade in financial instruments and is not exposed to interest rate price risk. The risk has not changed in the year.

### **Liquidity Risk**

Liquidity risk is the risk that the Organization cannot meet its financial obligations associated with financial liabilities in full. The main source of the Organization's liquidity is government funding and various grants used to finance the Organization's operations and is adequate to meet the Organization's financial obligations associated with financial liabilities.

Contractual cash outflows consist of accounts payable that are due within one year.

Liquidity risk may arise from unanticipated expenditures in excess of the financial capability of the Organization. It is management's opinion that the Organization is not exposed to significant liquidity risk from their financial instruments.

The risk has not changed in the year.

## **13. Economic Dependence**

The Organization's primary source of income is derived from the Province of Manitoba in the form of an operating grant.

## **14. Budget**

The Board approved its operating budget based on planned expenses and the use of unrestricted net assets to cover any excess of expenses over revenue for the year.

## **15. Comparative Figures**

Certain of the comparative figures have been reclassified to provide better comparison with the current year's presentation.

La Loi sur les divulgations faites dans l'intérêt public (protection des divulgateurs d'actes répréhensibles) est entrée en vigueur en avril 2007. # MESSAGE DE LA PRÉSIDENTE ET DE LA PRÉSIDENTE-DIRECTRICE GÉNÉRALE

**Au nom du conseil d'administration et du personnel de Musique et film Manitoba (MFM), nous avons le plaisir de vous présenter le rapport annuel de la Société pour l'exercice qui s'est terminé le 31 mars 2019.**

Le titre du rapport de cette année, *À la conquête de nouvelles frontières en cinéma et en musique*, témoigne de l'énergie palpable et de l'optimisme ressentis dans l'industrie du film et de la musique du Manitoba aujourd'hui. Le secteur est à un point critique, aux portes d'une croissance et d'un essor créatif sans précédent.

Cette année, la production cinématographique au Manitoba a atteint près de 270 millions de dollars — battant les records précédents et positionnant ainsi la province en tant que centre de production concurrentiel de prochain niveau. L'annonce du gouvernement du Manitoba relativement à la permanence du Crédit d'impôt du Manitoba pour la production de films et de vidéos permettra une croissance encore plus élevée — créant ainsi de la stabilité et des emplois et ayant un impact économique important partout dans la province. Immédiatement après l'annonce, les studios Amazon/Fox ont déclenché le tournage de la série à grand budget, *Tales from the Loop*, ici au Manitoba, ce qui démontre l'importance de la stabilité des incitatifs cinématographiques provinciaux. Les faits saillants de cette année, parmi beaucoup d'autres, incluent le tournage et la sortie de la deuxième saison de la série CBC *Burden of Truth*, maintenant renouvelée pour une troisième saison et qui sera tournée

au Manitoba au mois d'août 2019, le tournage de *Percy*, un récit canadien mettant en vedette Christopher Walken, co-développé et coproduit ici au Manitoba et le tournage de *A Dog's Journey*, marquant le retour d'Amblin à la suite du succès du film *A Dog's Purpose*. Cette année, la société de gestion et de production basée à Los Angeles, The Cartel, a ouvert une filiale à Winnipeg nommée Cartel Pictures Canada et a amené, au courant de cet exercice financier seulement, cinq projets au Manitoba. Nous présentons ces événements marquants, ainsi que d'autres, de manière plus détaillée dans la section « Faits saillants » de ce rapport.

Dans le secteur de la musique, les artistes manitobains continuent de recevoir des distinctions nationales et internationales. Cette année, les artistes financés par MFM ont reçu trois nominations aux prix Juno, huit nominations aux Western Canadian Music Awards et deux nominations aux

Prix de musique folk canadienne. Les artistes autochtones de notre province ont également eu un impact important cette année avec des nominations aux prix Juno (Leonard Sumner), une émission spéciale à la radio pour la BBC (William Prince) et des tournées internationales majeures. Certains des artistes musicaux manitobains les plus importants, dont Royal Canoe, Begonia, Yes We Mystic et d'autres, continuent de recevoir des critiques élogieuses, de placer leur musique dans des films hollywoodiens et de signer des ententes avec des entreprises de gestion d'artistes majeures. De plus amples détails sont présentés dans la section « Faits saillants » de ce rapport.



# Merci à Carole Vivier

Après 30 ans de carrière chez Musique et film Manitoba, l'année 2019 marque le départ à la retraite de la présidente-directrice générale et commissaire à la cinématographie, madame Carole Vivier.

Pendant ses années dans l'industrie, Carole a mené l'évolution de l'industrie du film et de la musique au Manitoba et en a fait un bel exemple de réussite internationale. Elle a orchestré la croissance du secteur de la production, passant d'une industrie modeste de huit projets par année à un volume de production de 269 millions de dollars en 2019. Carole, en tant que commissaire à la cinématographie, a contribué à attirer des projets de grande envergure tels que *Channel Zero, Heaven is for Real, A Dog's Purpose, A Dog's Journey, Shall We Dance, Tales from the Loop* et *Capote* (et beaucoup d'autres) à tourner au Manitoba et à coproduire avec des maisons de production locales. Du côté musique, le Manitoba reste l'une des provinces qui soutiennent le plus les artistes, en grande partie grâce au leadership de Carole chez Musique et film Manitoba. Carole a grandement contribué au fait que Winnipeg a été la ville hôte des prix Juno en 2005 et en 2014, et a soutenu la carrière de grands artistes manitobains, dont Chantal Kreviazuk, Doc Walker, Vince Fontaine, Royal Canoe, Begonia et plus encore. Elle a reçu l'Ordre du Manitoba, la Médaille du jubilé de diamant de la reine et le Prix hommage du conseil d'administration de l'Académie canadienne du cinéma et de la télévision. Elle est également membre du Temple de la renommée d'affaires du Manitoba.

Carole a été décrite comme la «lionne» du film et de la musique au Manitoba. Elle défend ardemment la province et les créateurs du Manitoba. Sa passion envers le travail des cinéastes et musiciens d'ici a touché des milliers de vies et a propulsé de nombreuses carrières. Elle nous manquera énormément.

## LE GOUVERNEMENT REND LE CRÉDIT D'IMPÔT PERMANENT

Dans un grand vote de confiance pour les industries des médias de l'écran de la province, le 15 janvier 2019, le gouvernement du Manitoba a annoncé que le Crédit d'impôt du Manitoba pour la production de films et de vidéos deviendrait permanent. À la conférence All Access d'On Screen Manitoba, la ministre du Sport, de la Culture et du Patrimoine, Cathy Cox, a été récompensée d'une ovation debout de la part des membres de l'industrie à la suite de son annonce qui a mis en évidence la reconnaissance de la valeur de l'industrie par la province. La suppression de la clause d'extinction envoie un message à l'industrie mondiale du film que le Manitoba est ouvert aux affaires à long terme. Cela bonifie particulièrement notre capacité à attirer de grandes séries, car les productions veulent assurer la stabilité sur plusieurs saisons. À la suite de l'annonce du gouvernement, les producteurs de



Les artistes autochtones du Manitoba ont eu un impact majeur au cours des dernières années avec des tournées internationales, des émissions spéciales à la radio, des prix, des nominations et plus encore. Depuis son émergence sur la scène musicale, il y a quelques années à peine, William Prince fait beaucoup de bruit dans l'industrie de la musique. Son premier disque de longue durée, «*Earthly Days*», lui a mérité le Juno pour l'Album roots contemporain de l'année et le prix pour l'Album autochtone de l'année au Western Canadian Music Awards. Prince, qui a signé une entente avec Glassnote Records, a lancé «*Earthly Days*» à l'échelle mondiale cette année qui lui a valu une importante émission spéciale à la radio de la BBC ainsi que plusieurs dates de tournée à l'internationale. Leonard Sumner, un auteur-compositeur-interprète anishinaabe du Manitoba, a été finaliste pour le prix Juno de l'Album autochtone de l'année 2019 et a accepté plusieurs engagements prestigieux au Canada et dans le monde. Indian City, l'un des piliers des groupes autochtones manitobains, a reçu trois nominations aux Indigenous Music Awards et a remporté le prix du Meilleur album pop pour son récent album, *Here & Now*.



## THE CARTEL ARRIVE AU MANITOBA

La société de gestion et de production basée à Los Angeles, The Cartel, a étendu ses activités au Canada cette année avec le lancement d'une nouvelle filiale, Cartel Pictures Canada, située à Winnipeg. La société, qui avait précédemment tourné quatre téléfilms pour Hallmark à Winnipeg, se concentre sur la production, le développement et le financement de téléfilms, de films indépendants et de séries télévisuelles. Au cours de cet exercice, Cartel Pictures Canada a réalisé cinq projets dans la province. Lors de l'annonce de l'ouverture de la filiale, la société a indiqué qu'elle envisageait de produire la moitié de ses projets à Winnipeg, soit environ 10 projets en 2019.



### TALES FROM THE LOOP

Après l'annonce de la permanence du Crédit d'impôt du Manitoba pour la production de films et de vidéos, Amazon et Fox 21 Television Studios ont annoncé qu'ils filmaient la grande série *Tales from the Loop* dans la province. Le tournage a déjà commencé à Winnipeg, Morden et les environs. Le drame de science-fiction est inspiré du travail du peintre suédois, Simon Stålenhag, qui mélange des éléments de science-fiction futuriste avec des images de vie rurale. Les séries sont particulièrement avantageuses, car elles permettent d'employer les équipes de tournage à long terme, elles offrent de nombreuses possibilités de formation professionnelle et elles permettent d'augmenter les investissements étrangers dans la province.

### ARIEL POSEN SIGNE UNE ENTENTE AVEC UNE GRANDE SOCIÉTÉ DE GESTION D'ARTISTES

Le guitariste et auteur-compositeur-interprète manitobain Ariel Posen a signé une entente cette année avec David Meszaros de Macklam Feldman Management, rejoignant une liste impressionnante de clients comprenant Elvis Costello, Diana Krall et James Taylor. Posen est un ancien membre du groupe roots-rock, The Bros. Landreth, lauréat d'un prix Juno. Son premier album solo, *How Long*, attendu depuis longtemps, est un album roots parsemé d'un soupçon de blues et décrit comme «un mélange de rhythm and blues et de rock and roll mélodique».

### PRODUCTIONS MANITOBAINES, HISTOIRES CANADIENNES

Un projet majeur s'est réalisé au Manitoba cette année. Le long métrage musical, *Stand!*, écrit, composé et produit par des Manitobains, a été tourné dans la province. La distribution était composée d'acteurs manitobains à 94 % et l'équipe de production était presque entièrement locale. Écrit par Danny Schur et Rick Chafe, *Stand!* raconte l'histoire de la grève de 1919 à Winnipeg, un événement qui changea à jamais les relations de travail au Canada. Le film sortira en 2019, l'année du centième anniversaire de la grève, et sera projeté dans le cadre de la série Projections tapis rouge de MFM au Centennial Concert Hall en septembre 2019. *Stand!* est produit par Jeff Peeler de Frantic Films et est réalisé par Robert Adetuyi, le réalisateur de *Bring it On* et *Stomp the Yard*.

Le film *Percy*, qui raconte l'histoire de Percy Schmeiser, un agriculteur saskatchewanais qui a affronté Monsanto dans une bataille juridique, a été filmé, co-développé et coproduit au Manitoba cette année. Le film met en vedette de grands talents comme Christopher Walken, Christina Ricci et Adam Beach et 78 % des acteurs étaient manitobains. C'est Ian Dimerman d'*inferno Pictures* qui a coproduit et co-développé le film.

### LE MANITOBA À LA CÉRÉMONIE DES PRIX JUNO

Les artistes financés par MFM ont remporté trois nominations au prix Juno cette année. L'album *Loved* de KEN mode (soutenu par le fonds d'enregistrements sonores niveau 3 de MFM) et l'album de Cancer Bats, *The Spark That Moves* (soutenu par le fonds d'enregistrement de musique par des artistes non résidents de MFM), ont été tous les deux sélectionnés pour l'Album de musique métal/hard de l'année. Le nouvel album de Leonard Sumner, *Standing in the Light* (soutenu par le fonds d'enregistrements sonores niveau 2 de MFM), a été sélectionné pour l'Album de musique autochtone de l'année.

# PARTENARIATS

La croissance des industries du cinéma et de la musique au Manitoba ne serait pas possible sans de solides partenariats et la collaboration de divers organismes. Musique et film Manitoba s'associe et apporte son soutien à plusieurs initiatives, tant sur la scène locale qu'internationale, dans le but de favoriser la création de débouchés pour les artistes et les entreprises de la province qui évoluent dans le domaine de la musique et du cinéma.

### INDIGENOUS FILM SUMMIT

Cette année, MFM a parrainé le tout premier sommet du film autochtone (Indigenous Film Summit), une initiative menée par le Manitoba's Indigenous Film Collective. Le sommet s'adresse aux écrivains, réalisateurs et producteurs émergents et professionnels, en leur proposant un espace de rencontre, d'échange d'idées et de réseautage avec certains des meilleurs professionnels du secteur. La conférencière d'honneur était l'actrice et productrice Tina Keeper. Cet événement a été un franc succès et fut bien accueilli par plus de 200 délégués et professionnels de l'industrie.

### LE FESTIVAL DU FILM DE GIMLI

MFM soutient depuis longtemps le Festival du film de Gimli. Cette année, le festival a considérablement accru ses initiatives de développement de l'industrie en mettant l'accent sur la mise en valeur du potentiel et des possibilités offertes aux réalisatrices et réalisateurs autochtones du Manitoba. C'était la première année du programme de mentorat *Future is Female*, qui vise à impliquer davantage de femmes et de personnes trans et non binaires dans le Festival du film de Gimli et dans la communauté cinématographique en général. Dans le cadre du programme, 45 participants ont été transportés à Gimli par autobus pour une journée de renforcement des capacités, de projections et de mentorat. C'était également la première année de la *Indigenous Film Series* du festival, une série consacrée aux projets présentés par des peuples autochtones du Manitoba, du Canada et du monde entier. MFM a également parrainé le Prix du public du court métrage au Manitoba (Manitoba Short Film Audience Choice Award), qui récompense l'excellence en réalisation de courts métrages dans la province.

# PRODUCTION CINÉMATOGRAPHIQUE ET TÉLÉVISUELLE AU MANITOBA

MFM existe pour contribuer à l'essor des industries manitobaines de production cinématographique et télévisuelle.

Nous y parvenons en participant à l'évolution et à la promotion des entreprises manitobaines ; en contribuant au développement, à la production et à la mise en marché de projets cinématographiques et télévisuels par le biais de nos programmes ; et en faisant la promotion du Manitoba comme lieu de tournage auprès de maisons de production de l'extérieur de la province. Notre objectif est la croissance des industries des médias de l'écran du Manitoba, et par conséquent la hausse des occasions d'emploi, la multiplication de la propriété intellectuelle et des droits d'auteurs et la stimulation de l'activité économique pour les fournisseurs de services locaux.

MFM est un membre de longue date de l'**Association of Film Commissioners International** (AFCI). En plus de gérer les programmes de film et les incitatifs fiscaux, MFM offre un éventail complet de services de tournage, notamment le dépouillement de scénarios, le repérage de lieux de tournage, ainsi que des services de liaisons auprès du gouvernement, des entreprises et de l'industrie. MFM a contribué à attirer des centaines de productions cinématographiques et télévisuelles, par exemple *Heaven is for Real*, *A Dog's Purpose*, *Percy, Siberia*, *Channel Zero*, *Tales from the Loop*, *Burden of Truth*, *Capote*, *Shall We Dance* et beaucoup d'autres.

Au cours de cet exercice, la valeur des productions réalisées dans la province a atteint 269,4 millions de dollars, battant le record de 173,3 millions de dollars de l'année précédente. Cette somme représente le total des budgets des

films tournés dans la province entre le 1<sup>er</sup> avril 2018 et le 31 mars 2019.

Grâce à ses programmes cinématographiques, administrés par MFM, le gouvernement du Manitoba a aidé à financer 8 longs métrages, 34 téléséries (fictives et factuelles), 15 documentaires uniques, 10 téléfilms, 2 émissions pilotes, 1 minisérie, 2 webséries et 3 courts métrages. Cette année, MFM a également reçu 129 scénarios/requêtes liés à des projets et a fourni des services de repérage complets à 15 projets par l'entremise de la Commission à la cinématographie pour des projets de coproduction ou de production de service au Manitoba.

MFM soutient depuis longtemps la programmation autochtone du National Screen Institute, notamment les programmes New Indigenous Voices et Indigidocs. Ces programmes ont aidé à former de très bons cinéastes autochtones au Manitoba qui sont de plus en plus reconnus au Canada et dans le monde. Les diplômés de ces programmes ont lancé la Indigenous Film Collective, une organisation à but non lucratif dédiée à l'intégration de la culture autochtone dans le cinéma, à la promotion du dialogue entre les différents groupes de la société, à l'autonomisation des cinéastes autochtones et à l'accès du public aux histoires autochtones. Ce groupe coordonne également le sommet du film autochtone (Indigenous Film Summit), un événement annuel couronné de succès qui rassemble les cinéastes pour renforcer leurs capacités, favoriser le mentorat, et plus encore.



# ACTIVITÉS DE PRODUCTION CINÉMATOGRAPHIQUE ET TÉLÉVISUELLE

Au cours de l'exercice 2018-2019, la valeur totale de la production a atteint 269,4 millions de dollars.

## CRÉDIT D'IMPÔT

Outre les investissements accordés par Musique et film Manitoba, le Crédit d'impôt du Manitoba pour la production de films et de vidéos constitue un incitatif essentiel pour attirer la production dans la province et permet aux maisons de production manitobaines de continuer à produire du contenu. Le crédit d'impôt très concurrentiel est un facteur clé dans la création d'emploi et dans l'apport d'investissements importants au Manitoba. Au cours de l'exercice, 128 demandes de crédits d'impôt ont été traitées. Cela représente presque 306 millions de dollars en activités de production. Remarque : Les demandes de crédits d'impôt et la production associée ne sont pas nécessairement traitées lors du même exercice, ce qui explique la différence entre le total du volume de production du crédit d'impôt et celui de l'exercice financier.

## FILM – UN EFFET LEVIER SUR LES AUTRES SOURCES DE FINANCEMENT

Avec l'aide des 49,8 millions de dollars provenant du crédit d'impôt et des investissements accordés par le Manitoba, 269,4 millions de dollars en activité de production locale, de coproduction et de production étrangère ont été générés. Ce qui veut dire qu'environ 81 % de l'investissement total en production provient d'autres sources de financement de l'extérieur de la province : la preuve que les modestes investissements du Manitoba peuvent générer des retombées de plusieurs millions de dollars pour l'économie locale.

# LA MUSIQUE AU MANITOBA

## Musique et film Manitoba existe pour contribuer à l'essor de l'industrie manitobaine de la musique.

Nous y parvenons en proposant des programmes de financement de projets musicaux qui contribuent à la croissance de l'impressionnante scène musicale de la province. De plus, MFM participe et apporte son soutien à divers festivals, conférences et vitrines musicales afin de maximiser l'impact de son financement en promouvant de manière efficace ses clients et en créant des occasions de réseautage pour les artistes manitobains.

Cette année, MFM a accordé 506 284 \$ de financement à 175 projets musicaux, représentant la principale source de soutien financier pour les musiciens émergents et établis du Manitoba. Les projets ont été financés par l'entremise du Programme de financement pour la production d'enregistrements sonores (niveaux 1, 2, et 3), du Programme de soutien à l'intention des artistes exécutants qui font des tournées, du Programme de soutien à la mise en marché d'enregistrements sonores, du Programme de financement pour la production de vidéoclips et de vidéos virales et du Programme de financement de production pour artistes à l'extérieur de la province. Les entreprises de musiques sont soutenues par l'entremise du Fonds d'aide aux entreprises de musique.

Les demandes soumises aux programmes de financement pour la production d'enregistrements sonores sont évaluées par jury et doivent être approuvées à l'unanimité par deux jurys. Les jurés sont composés de professionnels de l'industrie locale et sont choisis pour leurs connaissances approfondies dans leur genre de musique respectif. Il peut s'agir de producteurs, de diffuseurs, de gérants, de propriétaires ou de représentants de maisons de disques, d'artistes, de compositeurs, de professionnels des médias et de détaillants. Musique et film Manitoba remercie chaleureusement tous les jurés qui ont si généreusement donné de leur temps.

Les demandes soumises au Programme de soutien à la mise en marché d'enregistrements sonores, au Programme de financement pour la production de vidéoclips et de vidéos virales, au Programme de soutien à l'intention des artistes exécutants qui font des tournées et au Fonds d'aide aux entreprises de musique sont évaluées par MFM en fonction des plans de développement et de distribution, des antécédents de l'artiste, des horaires de tournée et de la solidité de l'équipe de soutien du demandeur.


## ACTIVITÉS DE PRODUCTION MUSICALE

Au cours de l'exercice 2018-2019, Musique et film Manitoba a accordé 506 284 \$ à 175 projets d'enregistrements sonores, de tournées, de mise en marché d'albums et de création de vidéoclips. Parmi ces projets, 40 participants se sont identifiés comme francophones, 13 se sont identifiés comme autochtones, et 44 ont déclaré faire partie d'une minorité culturelle.

MFM a versé 216 653 \$ à 57 projets d'enregistrement de musique et de vidéoclips dont les budgets ont totalisé plus de 600 000 \$.

Comme le financement provenant d'autres sources est souvent limité, les fonds accordés par MFM constituent la principale source de soutien aux musiciens émergents et établis du Manitoba. Le diagramme illustre le rôle primordial des investissements de notre organisme dans l'industrie manitobaine de la musique.

## Programme Accès aux marchés

En tant que volet du projet M3P, le programme Accès aux marchés est financé par Musique et film Manitoba et est administré par Manitoba Music.
